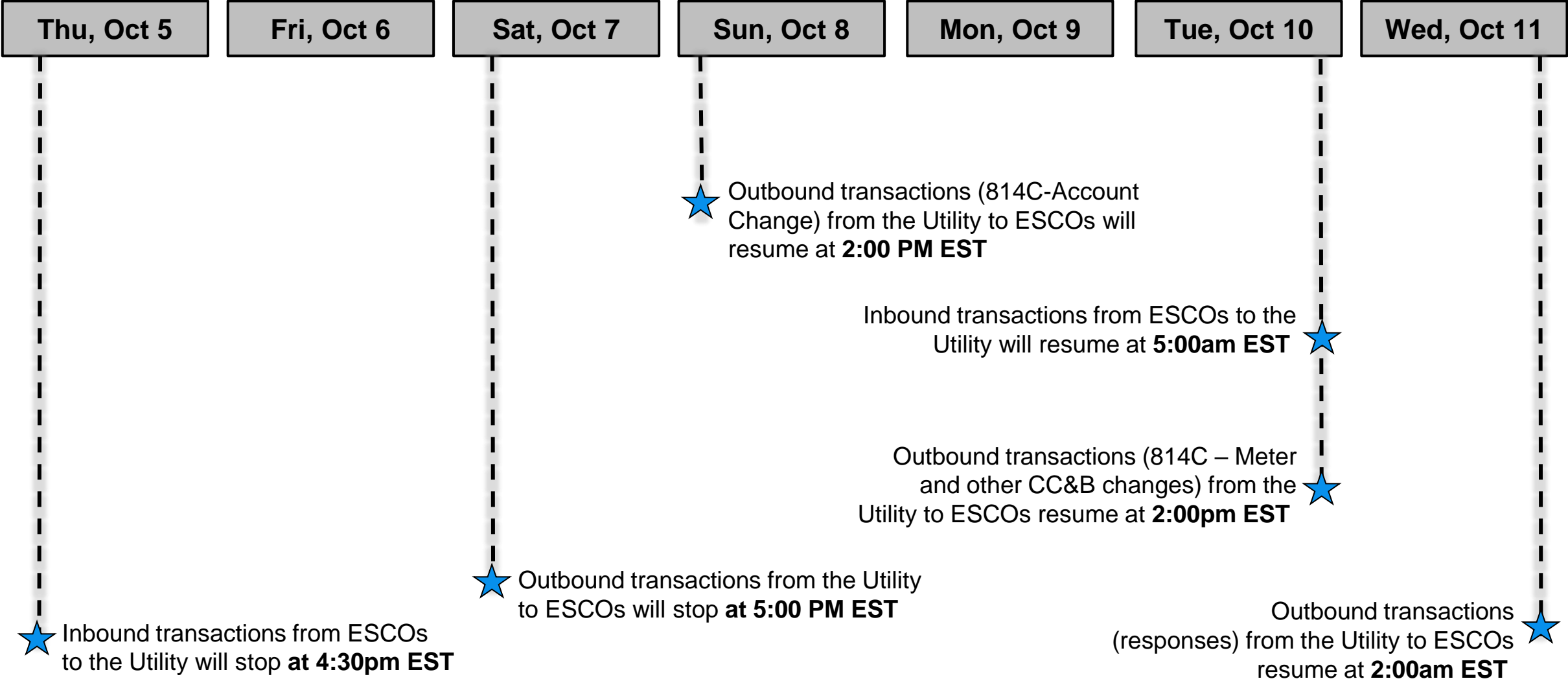
# Testing Update

# Testing Update

- **Dress Rehearsal 2 (DR2):** Practice run of the cut-over process was completed
  - Disconnect & reconnecting internal & external systems
  - Code deployment
  - Data conversion & validation
- **Operational Readiness Testing 2 (ORT2):** One week execution of the daily production transactions in a test environment was completed
- **Dress Rehearsal and Operational Readiness Testing (DR3 and ORT3):** Scheduled for 2<sup>nd</sup> & 3<sup>rd</sup> week of September
- **Additional internal testing:** Key transactions around usage, invoicing and remittance
